According to Section 5 of the Constitution of the association „Europäische Route der Backsteingotik e.V.“ that was approved by the Founding Assembly of its members on 26 September 2007, fees will be charged from ordinary as well as sponsoring members.

### Section 1 - Membership fees

1. The annual fee for **ordinary** members is graduated.
  - a. An ordinary member with the character of a local or regional authority or an organization or institution with activities on local/municipal level will be charged **EUR 2.500,00**
  - b. A partner of similar character like the one in paragraph 1a that cannot be an ordinary member due to the eligibility criteria has the possibility to join an ordinary member. The annual fee of the ordinary member will thus be raised by **EUR 600,00**
  - c. An ordinary member (in its nature of an institution/corporate body) may function as a coalition of at least four municipal corporate bodies or corporate bodies with activities on municipal/local level. The coalition has to be based upon a common cultural or geographical background. Finally, the Managing Board decides on membership, in particular in the light of the alternatives of full membership of the respective institutions. The coalition is formally represented by one of its members. It is charged an annual fee of **EUR 2.500,00**
2. The membership fee for **sponsoring** members is graduated.
  - a. Natural persons **EUR 40.00**
  - b. Associations, federations, foundations, chambers etc. **EUR 250.00**
  - c. Small businesses **EUR 350.00**
  - d. Medium and large businesses **EUR 600.00**

3. In case of the members' accession to the association at another point of time than the start of the year, a singular membership fee according to the remaining term of the year will be charged. This rule may be abandoned by the Managing Board represented by its Chair in individual cases. The aim is to involve new members already before the start of the new fiscal year. Natural persons are exempted from this rule, since they are charged only for a full year of membership.
4. For the year 2007 no membership fees will be charged.

### **Section 2 - Maturity of fees**

1. The fee according to section 1 paragraphs 1 and 2 needs to be transferred per year and in advance by 31 January.
2. The fee according to section 1 paragraph 3 is due with the approval of enrolment by the Managing Board and is to be transferred within 4 weeks after written notification about the membership.

### **Section 3 - Validity of the Fee Order**
